Personal comments by Mary


America is the land of the free, and the home of the brave. It is a place where anyone can do anything!



TAXES IN 1700S AMERICA

Taxation in the United States in 1776 was much different than it is today. There were no income taxes, nor corporation taxes and no payroll taxes. Instead, the American colonies were primarily funded by tariffs and excess taxes. Taxes primarily existed on imports of goods and services to the colonies, as well as on the sale of specific products – ships, tobacco, alcohol and sugar.

Despite taxes being the catalyst to a revolution, colonists paid very little in taxes. Tax burdens in the colonies were incredibly light, fat lighter than in England, and hardly enough to cover the costs of colonial administration. The problem was not that taxes were too high, but that they were arbitrary, punitive and most importantly, adopted without the consent of the governed. That is why "Taxation without representation is tyranny!" was practically a battle cry that we remember today.

Today our system of taxation is vastly different. In addition to having our tax policy decided by elected members of Congress, tariffs now make up less than 1% of federal revenue, compared to 90% of all revenue in the 1700's. We have far more taxes with higher rates today, but we did achieve taxation with representation.
