

# **CHANGES IN MEALS & ENTERTAINMENT TAX DEDUCTIONS**

When running a business, food, drink, and entertainment expenses are often incurred for marketing or operational purposes. However, the new tax bill has made it more difficult to deduct these expenses from your taxable income. Here's a recap:

# TO QUALIFY FOR THE MEALS TAX DEDUCTION, TAXPAYERS MUST MEET THE FOLLOWING CRITERIA:

- The expense is not lavish or extravagant under the circumstances.
- The taxpayer, or an employee of the taxpayer, is present when the food or beverages are provided.

#### **MEALS FOR TRAVEL**

You can deduct the cost of meals if it is necessary for you to stop for substantial sleep or rest to properly perform your duties while traveling away from home on business. This deduction applies only to the employee.

#### **MEALS PROVIDED WITH ENTERTAINMENT**

If food and beverages are provided during an entertainment activity, they will be treated as meals if the cost of the food and beverages is separately stated from the price of the entertainment.

#### **EMPLOYEE MEALS**

A 100% deduction is allowed for food or beverage expenses incurred by the taxpayer for a recreational, social, or similar activity such as holiday parties, annual picnics, and summer outings.

#### **CLIENT APPRECIATION EVENTS**

These remain 100% deductible.

#### WHAT IS NOT ALLOWED

No deduction is allowed for entertainment expenditures or for the use of a facility. This includes theaters, bars, country clubs, golf and athletic clubs, sporting events, and hunting, fishing, vacation, or similar trips. Dues or fees paid to any social, athletic, or sporting club or organization are also not deductible.

#### **NEW FOR 2026 - NOT TAX DEDUCTIBLE**

- Meals provided for overtime, staff meetings, or when staff cannot leave for a meal break
- Coffee, snacks, donuts, pizza, or lunch for staff

**Note:** "Food or beverage expenses" include the full cost of food or beverages, as well as any delivery fees, tips, and sales tax.



# **END-OF-YEAR SMALL BUSINESS TAX GUIDE**

### **GET YOUR BOOKS UP TO DATE**

Know where you stand! We don't want to miss any expenses, and accurate books give you the opportunity to manage your taxes effectively. Here are the basic steps:

#### Reconcile bank accounts.

This ensures that all deposits and payments are recorded accurately—and only once. Aim to reconcile your books by the 10th of the following month.

#### Record all expenses.

If you paid any business expenses personally, create an expense report and record those items before year-end. Don't forget to include business mileage on your personal vehicle the 2025 mileage rate is 70 cents per mile.

#### Review your fixed assets.

Obtain invoices for items over \$2,500 paid with cash or loans.

- Review your fixed asset list to identify anything that was disposed of or sold.

#### **COMPLIANCE ITEMS**

#### Review 1099 payments.

Payments made to independent contractors and LLCs may need to be reported in January. This includes rent, attorney fees, consultants, and other services. Verify that you have current tax information (W-9) for each vendor.

#### Payroll tasks.

- Overtime & tips: Confirm how overtime wages are calculated under the new IRS standards, and verify tips that qualify for the "No Tax on Tips" program.
- · Personal use of company vehicle: Record mileage and calculate personal use to add to taxable wages before the last paycheck of December.
- S corporation owner benefits: Determine the amount the company paid for owner health insurance. This must be included in W-2 wages—but owners receive a deduction for it.
